No. 318/CS-KL/2015(1).—WHEREAS, the President of India has, by notification issued under section 12 of the Representation of the People Act, 1951 (43 of 1951) and published in the Gazette of India on 30th March, 2015, been pleased to call upon the elected members of the Legislative Assembly of the State of Kerala to elect three members to the Council of States;

Now, THEREFORE, in pursuance of sub-section (1) of section 39 and section 56 of the said Act, the Election Commission of India hereby—

(A) appoints, with respect to the said election—

- (a) the 6th April, 2015 (Monday), as the last date for making nominations;
- (b) the 7th April, 2015 (Tuesday), as the date for the scrutiny of the nominations;
- (c) the 9th April, 2015 (Thursday), as the last date for the withdrawal of candidatures;
- (d) the 20th April, 2015 (Monday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 21st April, 2015 (Tuesday), as the date before which the election shall be completed; and

(B) fixes the hours from 9.00 A.M. to 4.00 P.M. as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
